The above listed module types are manufactured in the European Union. The manufacturing plant is under a periodic factory surveillance programme in the frame of TÜV Rheinland type approval certification according to IEC 61215:2005 and IEC 61730:2004.

These main production steps are taking place in the above listed plant:

- Cell stringing and connection of strings
- Assembly / Lamination
- Electrical tests

Remarks:

PV-module type "Serie S-Class Integration" consist of laminated PV modules with special frame type Solrif of Ernst Schweizer AG for building integrated installation (BIPV).
The complete system was tested with mechanical load according to IEC 61215:2005 test method with 2400 Pa tensile and 3800 Pa pressure load and waterproofness comparable to the traditional building elements that are substituted, with reference to the respective requirements of "DM 5 Luglio 2012, Art. 2, Art. 8 and Allegato 4".
